Courses offered include English as a Second Language (Levels I-IV), Adult Basic Education, General Equivalency Diploma (GED), Computer Skills Training and Workforce Training. Offered at two locations (CFC's main office and a leased facility in Southwest Houston), CFC utilizes the Texas Curriculum, which was designed by the Texas Educational Agency and promoted by the National Institute for Literacy. Classes are taught by degreed instructors who use a holistic approach to immerse students in the English language. The curriculum is coupled with a functional, real-life approach so that students can quickly learn new skills and practice their new found knowledge at home, at work, and in the community.

4b (Code: ) (Expenses \$ 391,723 including grants of \$ ) (Revenue \$ 63,829 ) Early Childhood Education: This program prepares preschool children from ages three to six for academic success by providing Montessori-based early education and training opportunities for parents to enhance their roles as primary educators for their children.

All Members of the Board of Directors receive a final draft of the Form 990 and are encouraged to submit any questions, corrections or concerns to the staff and independent auditors prior to filing with the IRS.

**02. Conflict of interest policy compliance (Part VI, line 12c)**

Directors, Officers, management and staff are required to comply with the organization's conflict of interest policy. The Organization enforces this policy by obtaining a signed acknowledgment from affected individuals on an annual basis.
